

## Request for Federal Direct PLUS Loan (Parent) Academic Year 2007-08

**A Federal Direct PLUS loan is specifically for the parent of a dependent student.** To qualify for a PLUS loan the applicant must be a natural parent, adoptive parent, or the stepparent of a dependent student.

To ensure loan proceeds will be available by the time school starts, please complete and return this form to the Financial Aid Office by July 25, 2007. Upon receipt of the completed form, the information is forwarded to the Direct Loan Servicer for a required credit check.

**First-time applicants** are required to complete a PLUS Master Promissory Note (PMPN) before funds will be disbursed. Upon credit approval, the Financial Aid Office will provide instructions on how to complete the PMPN. Applicants will have the option to complete a paper or electronic note.

**Previous PLUS loan borrowers** that already have a PMPN on file from the 07-08 academic year for the student named below, are not required to complete another PMPN.
