Biographical Note:

Sherry Folsom was born in Iowa City, Iowa. The family moved to Spencer Iowa where she graduated from high school. Then she went on to and graduated from Coe College in 1966. While there she was a member of the Kappa Delta Sorority.

In 1968 Sherry married Charles Meek and moved to Houston, Texas and then on to Overland Park, Kansas. Together they had one daughter, Patricia Lee "Trish", born in 1975. After a career in real-estate and a divorce she began graduate work. Her master's degree was attained at Kansas University in Lawrence, Kansas in adaptive physical education in 1983. Then Texas Woman's University was where she obtained her doctorate in 1986. Sherry taught at several universities prior to Minnesota State University at Mankato, where she remained until retiring in 2015. Dr. Folsom-Meek was internationally known for her work in the field of Adapted Physical Education. She was an education trailblazer and an early leader in efforts to study and advance the field of adaptive physical education, with numerous awards and published works. Sherry was a hands-on professional. She was a dedicated worker with Camp Courage, an organization established in 1955 to serve participants with developmental disabilities and special needs. The inspiration for this work came especially from her daughter.
