Collection Abstract

Benjamin DeWayne “B.D.” Silliman, a 1917 graduate of Coe College, served in both World War I and II, and was involved in the Nuremberg Trials serving on the staff of Supreme Court Justice Robert Jackson. The documents in the collection include interrogations from the Nuremberg Trials, prisoner information, and trial notes made by Silliman as well as personal memorabilia and photographs from Hitler's personal photographer.

Biographical Note

Benjamin DeWayne Silliman was born in Ardmore, Indian Territory (now southern Oklahoma) in 1895 and graduated from Boone High School in 1913. While at Coe, he majored in social science and was active in many student organizations including the debate team, Beta Phi Omega, oratorical societies and *Cosmos* staff. He graduated in June of 1917 and enlisted in the United States Army and served for a short time. He then taught at Washington High School in Cedar Rapids for two years before entering the University of Iowa College of Law. He received his degree and passed the bar in 1923 and practiced law in Cedar Rapids and instructed at Coe part time.

In 1942 he was called to active duty in the US Army and served with troops. He became Judge Advocate of the Northwestern Sector, Western Defense Command and then served on the staff of Justice Jackson at the Nuremberg Trials and was awarded the Bronze Star. He aided in transporting several high profile defendants to the Nuremberg Jail without incident including: Ernst Kaltenbrunner, Hjalmar Schacht, Fritz Sauckel, Karl Donitz, and Albert Speer. He personally discovered Walter Funk in a German hospital, trying to avoid trial, and brought him into custody. He was responsible for transporting thirty-one German witnesses to Nuremberg and also obtained a detailed confession from Fritz Sauckel. After the trials Silliman returned to the Cedar Rapids area and was active in various community events and served on the Board of Trustees of Coe College until his death in April of 1988.
